



#### **Preventive Flu Vaccines**

BlueCross BlueShield of South Carolina BlueCross BlueShield of South Carolina always wants its members to stay healthy. Since we are in the flu season, we encourage eligible members to get their flu vaccines to reduce the chance of infection.

Members can get flu vaccines covered under their pharmacy benefit at any in-network pharmacy with no cost share. Those that choose to go to an out-of-network pharmacy will be responsible for the full cost.

Who is covered? Members that have nongrandfathered fully insured, self-insured and exchange plans are eligible for coverage.

### **Reminder: Medicare Advantage and Cotiviti**

On Sept. 1, 2022, BlueCross' Medicare Advantage plans began working with Cotiviti. Cotiviti is a leader in payment accuracy for periodic reviews of paid medical claims.

Cotiviti uses Clinical Chart Validation (CCV) to conduct post payment audit validation in the review of inpatient claims.

These reviews ensure proper billing and require a copy of medical records for the following inpatient services:

- Diagnosis Related Group (DRG)
- Observation (OBV)
- Readmission (RAD)

If a claim is identified for review, you will receive a letter identifying the claim(s) selected. Details related to the guidelines and time frames to submit the required medical records will follow.
